Like the beacon in a lighthouse, we want the Pregnancy Help Center to be a light shining to women and families facing an unplanned pregnancy so that they may Let Life Shine. We want them to be guided to the Center where they can find:


- · Hope and help where often there is none
- Encouragement when it is needed most
- Kindness and compassion when they have no one to turn to

Because of YOU, we can offer this compassionate care when a woman is at a very vulnerable time.

The (recent) Prop 1 amendment to the California Constitution increases the urgent need to provide lifesaving alternatives to the abortion minded. State law now declares that "every individual possesses a fundamental right of privacy with respect to personal reproductive decisions and prohibits the state from denying or interfering with a person's right to choose

or obtain an abortion before viability of the fetus, or when the abortion is necessary to protect the life or health of the person" which in effect does not limit abortion to "before viability".

Chemical abortions now account for over 53% of all abortions. This number continues to grow as abortion pills (Mifepristone and Misoprostol) become increasingly available through the mail <u>without</u> a medical exam. Chemical abortion is still promoted as being "safer than Tylenol", despite the fact that thousands of women have been injured and even died after attempting chemical abortions due to an undiagnosed ectopic pregnancy or her baby is past the 10-week gestational age limit. If women do not reveal their use of the drugs in the ER, it may be miscoded as a miscarriage. If the Rh factor is not determined, this may jeopardize future pregnancies.



Additionally, there has been:

- An increase in the intentional spreading of false information about licensed pregnancy medical clinics like ours
- Suppression of ads by Google
- Disclaimers on both Yelp and the County of Los Angeles Public Health Department website. These disclaimers advise women to beware of misleading advertising from "Crisis Pregnancy Centers" claiming they "look like health care clinics" and "often provide false medical information."

Consequently, our pregnancy test client numbers declined in the last half of 2022 in contrast to record numbers in 2021. To meet these challenges, we revamped our marketing efforts in January to focus on specific strategies to attract more clients with unplanned pregnancies and especially those seeking chemical abortion pills. Pregnancy test client numbers began rising in April, and May was one of the highest months ever.

As the need for our services continues to grow, we are looking at adding additional programs, personnel to support them, and a larger facility in a more strategic area. We ask for your continued prayers in this endeavor; for our clients, staff, and volunteers; and for God's wisdom, guidance, and clarity as we continue to Let Life Shine.


