## POST-ROE: A NEW CHAPTER BEGINS FROM THE EXECUTIVE DIRECTOR AND BOARD CHAIRPERSON

Dear Friend of the Center,

Praise God! We now have a new anniversary to celebrate – June 24, 2022, when miraculously our prayers were answered. Roe v. Wade has been overturned! While we at the Pregnancy Help Center celebrate this milestone, we know that we need to redouble our efforts in this post Roe environment. Although we are rejoicing this victory, the battle for life has not ended. Overturning Roe will not stop all abortions; now the issue of abortion and restrictions has been returned to the states. As reported in the LA Times on May 2, 2022, “*Last September, Gov. Newsom asked Planned Parenthood Affiliates of California and dozens of other supporters to develop a plan for the state to become a sanctuary for anyone denied abortion services in other parts of the country. The coalition, the California Future of Abortion Council, recommended 45 changes to improve access for residents and create additional capacity should other states outlaw abortion.*”

In response to Gov. Newsom and Planned Parenthood's desire to expand their services, the pro-life community must be ready to meet this challenge. The Pregnancy Help Center is the only pro-life pregnancy medical clinic in the South Bay. Our mission is to help every woman facing a crisis pregnancy.

We offer a free pregnancy test followed by a free ultrasound, which has led 83% of our abortion-vulnerable clients to make life-affirming choices. In addition, we provide information, education, and practical assistance to eliminate the crisis and help her and her family choose life for her baby.

With four abortion clinics within a five-mile radius of the Center, we are increasing our digital marketing efforts to notify all who come to the South Bay of the life-affirming services we offer. We are planning to expand our facilities to serve more clients as they come to California from other states. We are NOW more committed than ever to provide clients with the compassionate care they deserve when facing an unplanned pregnancy, so they may find unexpected hope that enables them to confidently step into their vocation of motherhood.

In addition, we continue to be well connected to all of the pro-life organizations in the South Bay.

We urge you to pray for our clients, their babies, and for the safety of all our staff and volunteers. Join with us in contending for the lives of the preborn and their families, through volunteering or through financial support.

The Pregnancy Help Center helped women prior to Roe v. Wade and during Roe v. Wade, and we will be here for women now in a post-Roe world. Please review our donor site for more details: [Supportphctorrance.org](http://Supportphctorrance.org).

# THE HOPE YOU GIVE THEM

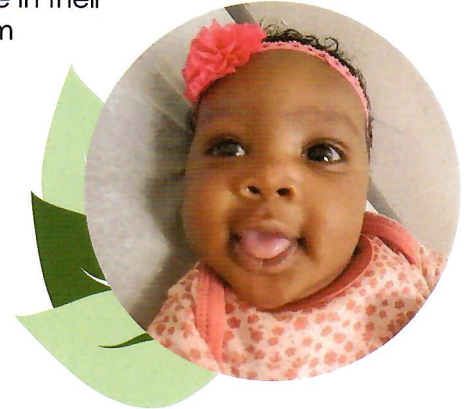
When faced with the challenges of an unexpected pregnancy, what women truly need is a sense of hope about the future. That's exactly what Everesha found in client advocate Susan.

Everesha was in a tough spot when she found out she was pregnant. Her son was only 10 months old; how could she manage two babies at the same time? To make matters worse, she was in an unstable relationship. With doubts in her mind and thoughts of abortion, she went online to find help in weighing her options. Her search led her to the Center.

During her appointment, she met with Susan, a client advocate. She felt so at ease with Susan that she was

able to share from her heart, and they had an intimate conversation about her situation. "I felt a burden lifted off me. Susan helped me come to the conclusion that I want to keep my baby." Everesha gave birth to a beautiful baby girl, Zoya, this year and the family is doing well.

With pro-abortion media often meeting unplanned pregnancy with cynicism, women in crisis need someone in their corner reassuring them of how capable they really are. Thank you for being there for our clients, the hope you give them is life changing.

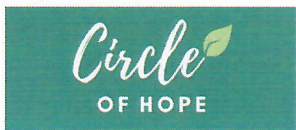
